BUS #3 - KING OF PRUSSIA & PHILADELPHIA

DEPARTURE and RETURN: Buses depart from the **HUB PARKING LOT** at 3 p.m. on **Friday, November 16, 2018**. Buses will drop passengers at Seasons 52 Restaurant off of N. Gulph Rd at the KOP Mall for **King of Prussia** and 23 S 30th Street (between Market and Chestnut) for **Philadelphia**. Buses will return to IUP from the following locations and times on **Sunday, November 25, 2018**: 23 S 30th Street at 3 p.m. for **Philadelphia** - Seasons 52 Restaurant at 4 p.m. for **King of Prussia**. Expect to return to Indiana by 9:30 p.m.

SWITCHING BUSES: Your original ticket purchase for a particular bus is **final**. **NO SWITCHING BUSES PERMITTED!**

I-CARDS: You **MUST** show your IUP I-card each and every time you board the bus. Please have it ready.

REFUNDS: THERE WILL BE **NO REFUNDS!** NO EXCEPTIONS! This round-trip ticket to King of Prussia & Philadelphia costs \$90.

TRANSFERS: THERE WILL BE **NO TICKET TRANSFERS!** You may **NOT** sell your ticket to another person.

BAGGAGE: EACH PERSON IS PERMITTED **ONE SUITCASE** (under the bus) AND **ONE CARRY-ON BAG** (with you on the bus) **ONLY!** BAGGAGE RESTRICTIONS WILL BE **STRICTLY ENFORCED**. Anyone attempting to load any large or bulky items, such as trunks, boxes, electronics, refrigerators, etc., will be instructed to remove these items from the bus. Failure to do so will prevent the bus from departing. The bus will not be held in order to enable you to find storage for such items. The Student Cooperative Association and Mlaker are **NOT** responsible for lost, stolen, or damaged luggage.

STOPS: Other than the final destination, there will be only one stop for food on each leg of this trip. No other unscheduled stops will be made. This food stop will be made at the **SIDELING HILL SERVICE PLAZA** (milepost 172.3, between exits 12 & 13) on the PA Turnpike, and will be used for the departure and return trips. **Follow instructions, and be timely. Buses won't wait for stragglers.**

MISSING THE BUS: The Student Cooperative Association and Mlaker will not be responsible if you miss the bus.

As a condition of their chartered contract, the driver of the bus is required to report all violations of University policy and local, state and federal law. If any passengers' behavior becomes intolerable, the passenger will be removed from the bus and will be responsible for their own transportation. Passengers may be refused transportation at the discretion of the driver. The passenger is responsible for any damages to the bus caused during the trip. The bus patron must bear in mind that his/her person and property are subject to search by duly warranted law enforcement officials at any time. The Student Cooperative Association and Mlaker Bus Lines will not be responsible for any vehicle damage or loss at the pickup sight.
